

Who can get a CIRI Descendent Identification (ID) Card?

Direct lineal Descendants (e.g., the children, grandchildren, great grandchildren, etc.) may receive a Descendant ID Card, once the relationship to a CIRI Shareholder is established and is confirmed by the Shareholder Relations Department.

Why identification cards?

- Use the card to check in at CIRI events.
- Present the card to vendors and Shareholder and Descendant business owners that provide Descendant discounts. [CIRI Benefits Page](#)
- The cards indicate whether the bearer is a direct lineal Descendant of an Alaska Native CIRI Shareholder and may assist in proving eligibility to receive services from various agencies and organizations.
