### **Earthquake Update**

At 8:29 a.m. on Friday, Nov. 30, a magnitude 7.0 earthquake struck Southcentral Alaska. The epicenter was about 10 miles north of Anchorage, with tremors felt as far away as Fairbanks. Residents have experienced many aftershocks in the days and weeks since.

I am profoundly grateful to share that no deaths or serious injuries occurred as a result of the quake. After the 1964 Good Friday earthquake, Alaska adopted some of the most stringent building standards in the nation to help structures withstand seismic activity.

CIRI's corporate headquarters at 725 East Fireweed Lane fared very well, with only minor damage. We are indebted to the architects, building code enforcement officers, contractors, designers and engineers who assisted us in constructing such a strong, safe building.

We were very sorry to have had to cancel CIRI's Fifth Annual Holiday Craft Bazaar. Work and safety crews were occupying our building the weekend after the quake, assessing damages and cleaning up broken glass and other debris. For the health and safety of all involved, it was necessary to cancel this year's event.

We look forward to seeing everyone at next year's Craft Bazaar. Until then, we encourage you to support CIRI's family of artists throughout the year. CIRI gives Alaska Native artists the opportunity to sell their handmade crafts every Tuesday and Thursday at the Fireweed Business Center. #### **Helping our Neighbors**

While CIRI was fully operational the Monday after the quake, others were not so fortunate. The building that houses CIRI-affiliated nonprofits The CIRI Foundation (TCF), Cook Inlet Tribal Council (CITC) and Koahnic Broadcast Corporation/KNBA 90.3 was badly damaged.

- Although we are not sure when TCF's offices will return to full service capacity, until such time occurs, CIRI is pleased to offer TCF temporary office space in our building. TCF has set up basic and limited operations, including email, its online application system and main phone line. Please note that staff are not set up to assist applicants in person at this time.
- CITC's efforts to relocate programs and services as quickly and efficiently
  as possible remain ongoing. Staff have set up temporary offices in
  locations throughout Anchorage, and the majority of CITC departments
  and subsidiaries are operating at 100 percent or near complete service.
  Employee capacity and participant services have resumed at some level
  across all departments.
- KNBA 90.3 operations have temporarily relocated and the station is broadcasting at a limited capacity. KNBA and Native Voice One streaming services are not available, while The RIVR stream is running.

We are grateful that the staff of TCF, CITC and KNBA are safe and well. The most up-to-date information is available on each organization's website and/or Facebook page.

#### **CIRI Office Closure**

As a reminder, CIRI offices will be closed Monday, Dec. 24 through Tuesday, Jan. 1, and will reopen at 8 a.m. Wednesday, Jan. 2. We look forward to serving our shareholders in the New Year! - The <u>Youth Educational Incentive Prize</u> drawing deadline is 3 p.m. Alaska Standard Time on Thursday, Jan. 31. This date is also the deadline for IRS Forms 1099 to be mailed to shareholders (available in the <u>Qenek</u> portal earlier).
