My fellow CIRI shareholders:

COVID-19 has caused massive changes to our pre-pandemic way of life. Many of us are balancing the challenges of work and being home with children while daycare centers have closed and summer camps have been cancelled, and there is uncertainty surrounding the upcoming school year. I know that all over the country, some of us have not seen coworkers or customers — or even family or friends — in person for some time.

Please know that you are not alone. Amid the spike nationwide in COVID-19 cases, we are all juggling fears, challenges and new responsibilities. And because the pandemic has forced us all to adapt to a rapidly evolving situation with no clear end date, we are also feeling stress.

In a recent Kaiser Family Foundation poll, nearly half the respondents felt the pandemic was harming their mental health. If you are suffering from anxiety, depression or substance-use disorders due to the COVID-19 pandemic or for any other reason, I encourage you to visit the Substance Abuse and Mental Health Services Administration website or call (800) 622-HELP.

Alaska Native and American Indian people living in Anchorage, the Matanuska-Susitna Borough and nearby villages may also access Southcentral Foundation's (SCF) behavioral health services by visiting the <u>SCF website</u> or by calling (907) 729-3300.

Our mental health is just as important as our physical health. We owe it to ourselves and our loved ones to seek support if we experience negative changes in thinking, mood and/or behavior.

Get Out the Native Vote

Each election year, millions of Americans miss the opportunity to vote because they didn't register. Our democracy doesn't work unless all eligible voters can access the ballot box, and that starts with registration!

Although the deadline to register or update registration for Alaska's primary election has passed, Alaskans have through Oct. 3 to <u>register</u> to vote or update any outdated voter registration information for this year's general election. They may also easily <u>apply</u> online for absentee ballots for the 2020 primary election (Tuesday, Aug. 18) and general election (Tuesday, Nov. 3). Alaskans do not need a reason to request a ballot by mail or to vote by mail!

2020 U.S. Census

Some people may wonder why they should bother to participate in the U.S. Census, particularly this year, when many are struggling with job loss and other economic hardships. But challenges such as these are precisely why it is important to respond to the 2020 Census.

Each person who responds to the census increases the amount of money and resources available to his or her community for the next decade, with census data informing where more than \$675 billion is distributed each year to communities nationwide. Given the record number of individuals currently filing for unemployment and other social services, even if your family doesn't rely on those resources, your community does.

Currently, the national self-response rate for the Census is slightly over 62%, but Alaska's self-response rate is lagging behind at less than 50%. Within the Cook Inlet region, Anchorage is faring better, with a response rate of approximately 61%, but the Matanuska-Susitna and Kenai Peninsula Boroughs are trailing, with response rates of approximately 33% and 39%, respectively, and return rates in most other areas of Alaska are even bleaker.
