## CIRI CELEBRATES 2022 SUMMER INTERNS

As part of our commitment to CIRI Shareholders' and Descendants' education and career advancement, in 2015 CIRI significantly expanded its summer internship program, placing six CIRI youth in positions with CIRI departments and subsidiaries.

Over the past seven years the program has flourished, with CIRI hosting or placing more than 40 summer interns with CIRI subsidiaries or Native-serving organizations.

When the COVID-19 pandemic arrived in the U.S. in early 2020, CIRI made the difficult decision to temporarily suspend its summer internship program. In 2021, CIRI hosted a modified program, with interns engaging in a combination of in-person and remote work.

This year, CIRI was pleased to host five full-time summer interns at the Fireweed Business Center, the company's corporate headquarters in Anchorage. CIRI's summer internship program creates opportunities for students and recent graduates to immerse themselves in Alaska Native culture, directly apply their education in a practical work setting, and gain insight into CIRI's culture and businesses.

"We love the youthful energy and innovative ideas our summer interns bring to the table!" said Darla Graham, associate director, CIRI Shareholder and Descendant Programs. "We are grateful to have a full slate of interns for the first time in two years, and utilizing their skills and knowledge for the betterment of our corporation. At the

same time, our interns benefit from exposure to different career possibilities, mentorship opportunities, and personal and professional development."

# A WORD FROM OUR PRESIDENT

It's hard to believe we are more than halfway through 2022. Here in the Cook Inlet region, the leaves have already begun to turn, the sun is setting earlier, and Alaskans are filling their freezers with silver salmon, lowbush cranberries and other wild foods.

2022 has been a challenging year for well-managed businesses throughout Alaska and across our nation. While we cannot know for certain how the U.S. and global economies will ultimately affect CIRI and its investments, the corporation is projecting substantially less net income this year, compared to what was initially budgeted for 2022 or the gains seen in 2021.

CIRI's outstanding performance in 2021 came at the height of an impressive market cycle, and we are now facing significant headwinds from increasing interest rates, inflation, geopolitical tensions and supply chain challenges. CIRI is expecting its marketable securities segment to see unrealized losses that are the result of the current downward trend in the markets. Revenue from CIRI's other segments of the corporation's diverse portfolio will protect the company from significant losses, though net revenue will be substantially lower than 2021's results.

Due to supply chain challenges and rising labor costs, CIRI's Government Services segment is also sensitive to projection uncertainty.

Economists predict a looming recession, with inflation curbing Americans' ability to spend and the Federal Reserve rapidly pushing up borrowing costs. Recent reports have shown falling consumer confidence, a slowing housing market, jobless claims rising and the first contraction in business activity since 2020.

It is impossible to say when the economy will stabilize, and CIRI is not immune to the recessionary environment, budget uncertainty, and the operating restrictions and supply issues caused by the ongoing COVID-19 pandemic.

CIRI prides itself on a well-diversified portfolio of business operations and investments. And history shows that stock prices can fluctuate widely over the short term, with the underlying value of solid business assets realized over longer periods. Through investments in credit funds and private companies, CIRI's private equity portfolio has some insulation from the broad impacts of the public markets.

Setting aside the impact of the market conditions in both marketable securities and private equities, CIRI is forecasting to slightly exceed original budget across remaining segments. Even in this time of uncertainty, your corporation continues to seek solid investments that are innovative and produce value for our Shareholders, and we are well positioned to weather the 2022 market downturn through a healthy balance sheet and strong liquidity.

Much can change between now and the end of the year, and complete financial performance information will be fully understood in the first quarter of 2023.

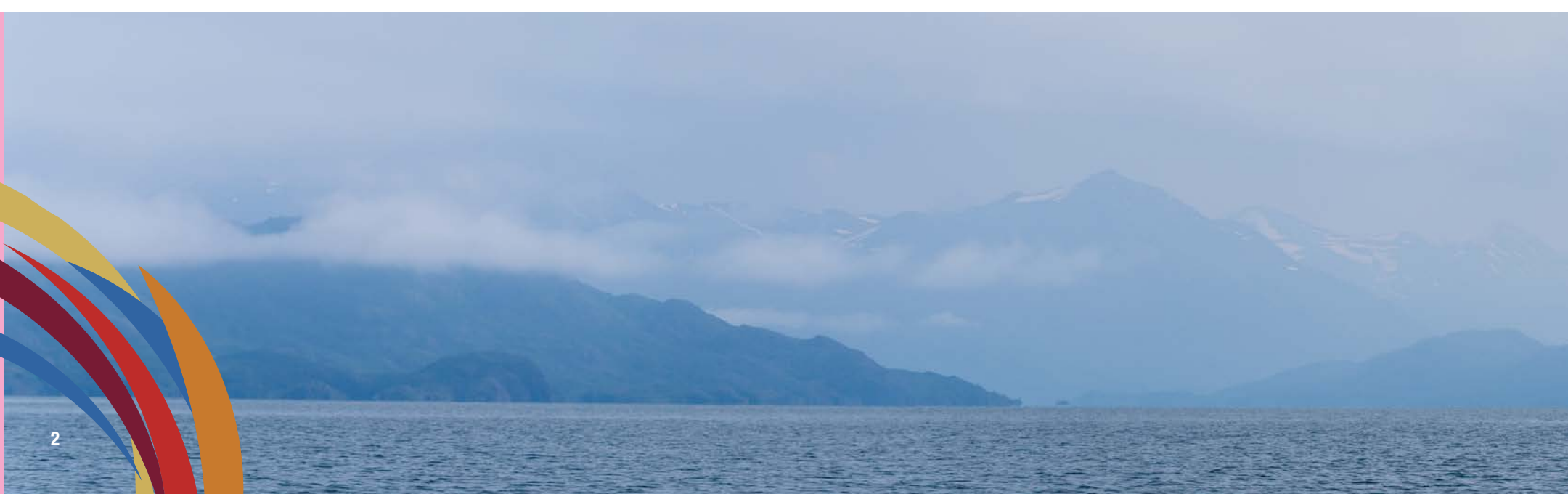

# CHARLES ANDERSON JR.

## Former CIRI Board Chair Passes Away at 92

Original CIRI enrollee Charles “Chuck” Anderson Jr. (Unungan/Aleut) passed away March 30 at home in Anchorage. He was 92.

Anderson served on the CIRI Board of Directors from 1987 to 2016 and as its chair from 2005 to 2013. He served on numerous other boards and commissions, including as vice chair of Southcentral Foundation (SCF). In 2012, the National Indian Health Board recognized Anderson’s SCF service by honoring him with a prestigious award for his dedication to improving the health and well-being of Alaska Native and American Indian people.

Anderson spent his early years on Long Island, Alaska, near Kodiak, where he and his family were the sole inhabitants. When he was 7 or 8, his family moved to Kodiak, where they owned a mink farm and lived a subsistence lifestyle. After serving in the Korean War, Anderson joined the Anchorage Police Department in 1953, moving up the ranks and serving as chief of police from 1974 until his retirement in 1980. He was a graduate of the FBI Academy and the Keeler Polygraph Institute.

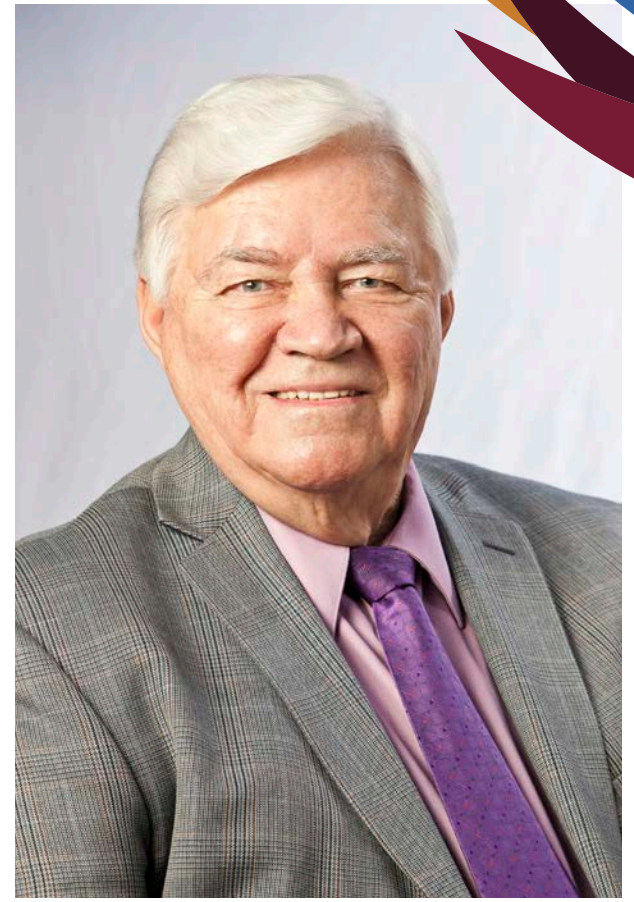
After retiring from the police force, Anderson was elected to the Alaska State House of

Representatives, serving one term (1981-1982). “But I wasn’t happy,” he said. “I didn’t care for partisan politics. In law enforcement, I could make a difference in people’s lives. I had to raise money in the legislature; I did not like asking people for help.”

The CIRI Board of Directors was a better fit. “Very refreshing,” he said. Anderson’s vision for CIRI was to remain an Alaska Native-owned company that provided a consistent stream of distributions, supported Elders through a trust fund, and provided jobs, health care and housing through affiliated non-profit organizations. Over the years, he helped make that vision a reality.

“We are saddened by Chuck’s passing, but we are grateful for his many years of service to CIRI,” CIRI President and CEO Sophie Minich said. “Chuck was known for his wisdom, kindness, level-headedness and pioneering spirit. He will be sorely missed by his CIRI family.”

Anderson was preceded in death by his son, Charlie Anderson. He is survived by his wife of 70 years, Georgia; daughter, Patti Juliussen; grandson, Charles “Chas” Anderson IV; granddaughter, Katrina Juliussen-Mack; and numerous other friends and family members.

My name is Lauren Culhane, and I am honored to intern with CIRI in the Corporate Affairs department this summer. I am connected to CIRI through my father, Tim Culhane, and my grandmother, the late Sharon Lee Oskolkoff-Culhane, both original CIRI enrollees. I was born and raised in Anchorage and currently attend the University of Colorado Boulder, pursuing degrees in media studies and sociology.

My family are members of the Ninilchik tribe, which was strongly influenced by the Russian Orthodox church and comprises a blend of cultures, primarily Athabascan, Alutiiq/Sugpiaq and Unungan (Aleut). Growing up, I learned what it means to be a proud Alaska Native person primarily from my grandmother and other members of my father’s family. Although I obtained a valuable education from the Anchorage School District, the curriculum did not include the rich history, vibrant culture and beautiful traditions of my heritage.

My grandmother, Sharon, resided in Ninilchik until her passing in 2018. Since

her mother was Russian and her father was a member of the tribe, she embodied the two most dominant cultures in Ninilchik. She taught her children and grandchildren subsistence fishing, how to clean the fish with an ulu, clamming and, most importantly, how to prepare traditional Russian and Native dishes. This year, thanks in part to my late grandmother’s efforts, the Holy Transfiguration of Our Lord Chapel in Ninilchik (built in 1901) will be recognized as a historic landmark, ensuring that valuable culture and artwork will be preserved and maintained for future generations. Additionally, my aunts and great-uncle are working to develop the Q’eschił Heritage Center, which will honor the distinctive identity and heritage of the Ninilchik tribe.

As we look ahead to the next 50 years, I feel that CIRI can best serve its Shareholders and Descendants by encouraging young people like myself to learn about and celebrate our Alaska Native history, and providing Shareholders and Descendants educational



and cultural program opportunities. Ultimately, to establish a strong future with visionary leaders, we must preserve and honor our past.

**RECIPE**

# AKUTAQ

*Akutaq, also known as “agutak,” is an Alaska Native dessert made with different ingredients depending on the region. It consists of whipped fat mixed with berries, with optional additions such as fish and sugar. The word in the Yup’ik language means “something mixed.”*

**MODERN RECIPE BY MARGE NAKAK (YUP’IK AND INUPIAQ)**

**INGREDIENTS:**

- 1 1/2 cups berry-flavored yogurt, such as Yoplait
- 1 or 2 bananas, mashed
- 2 cups cut, mashed strawberries
- 4 pounds frozen mixed berries
- Honey or sugar (optional, to taste)

**DIRECTIONS:**

1. Fold bananas into yogurt
2. Gradually add strawberries and frozen mixed berries, stirring well. The frozen berries will harden the mixture into “ice cream.” If using, add honey or sugar to taste.

**TRADITIONAL RECIPE BY GERI HOOGENDORN OF KOYUK, ALASKA**

**INGREDIENTS:**

- 1 pound dried reindeer fat, grated or shredded
- 1/4 cup seal oil
- 2 cups frozen salmonberries
- 3 cups frozen blackberries
- 1/2 cup sugar
- 1 1/3 cup boiled, flaked fish (optional)

**DIRECTIONS:**

1. In a large bowl, slowly add seal oil to the reindeer fat and whip by hand or with a hand mixer. If needed, add a bit of water. Keep mixing until mixture is white and fluffy.
2. Fold in berries, sugar and, if using, flaked fish.

## CIRI SUMMER INTERNS VISIT CHICKALOON

When we arrived in Chickaloon—a 90-minute drive northeast from Anchorage—we were greeted by CIRI Shareholder Chief Gary Harrison (Ahtna Athabascan) and CIRI Descendant Angela Wade (Ahtna/Dene), the council's tribal historic preservation officer. A one-way dirt road led us into the depths of the forest by the Chickaloon River. We formed a circle, and Angela led the group in prayer and established the intentions for the day.

Angela functioned as the primary guide and described the present state of tribal lands and her efforts to preserve her family's heritage through recent archaeological discoveries. She shared that she was curious about determining

whose land lays in the vegetation beyond her late grandmother's cabin and told stories about her family as we toured the grounds.

When she described the many trees that were visible from her grandmother's cabin, she pointed to one species and said, "These trees are quaking aspen, and my grandmother would say she would come out here and see the trees shimmer in the wind." I thought it was remarkable we could be standing in the same spot as Angela's grandmother and see the same trees she had seen.

It reminded me how essential "place" is to our connections to our families' past, and that returning to the land of our ancestors is a form of healing. When I

visit my grandmother's house in Ninilchik, I feel the same way Angela does. Angela and I are from different tribes with their own distinctive geographies, but as Alaska Native people, we share the same perspective on the significance of location. Preserving our cultural heritage helps maintain our integrity as a people.

Archeological discoveries on tribal lands are essential to preserving Alaska Native identity and transmitting Indigenous ways of knowing from one generation to the next. The efforts of organizations like the Chickaloon Village Traditional Council promote Alaska Native cultural identity and impart a deeper understanding of our place in the world.

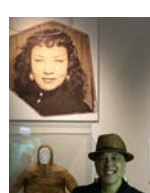
## BOOK RELEASE: RUTH ANN OSKOLKOFF

## CST Elders Distribution

Third quarter payments from the CST (CIRI Settlement Trust) Elders Distribution Fund will be mailed or directly deposited by 6 p.m. Alaska Standard Time on Friday, Sept. 9 to eligible Elders with a valid mailing address on file as of 3 p.m. on Thursday, Sept. 1. CST beneficiaries who are original CIRI Shareholders and are 65 years of age or older on the record date of Thursday, Sept. 8, 2022, are eligible to receive the \$450 payment, providing they either own at least one share of CIRI stock or gifted all their CIRI stock to family members prior to July 31, 2003.

## CST Distribution Fund

Third quarter payments from the CST Distribution Fund, in the amount of \$10.01 per share (or \$1,001 per 100 shares), will be mailed or directly deposited by 6 p.m. Alaska Standard Time on Friday, Sept. 30 to all CST beneficiaries who own CIRI stock and have a valid mailing address on file with CIRI as of 3 p.m. on Thursday, Sept. 22.

## Direct/Remote Deposit

CIRI urges Shareholders who receive their distributions in check form to consider signing up for direct deposit or taking advantage of remote deposit. Both options are fast, easy and environmentally friendly. (Note: When remotely depositing a check, it's a good idea to make a note on the check so you don't attempt to cash it again. If a check is cashed twice, you are legally liable to repay the amount of the overpayment.)

Shareholders who participate in direct deposit and have a current CIRI mailing

address are also eligible to participate in quarterly prize drawings.

Direct deposit forms are available from Shareholder Relations and at [ciri.com](http://ciri.com).

To cancel direct deposit, please submit a signed, written request prior to 3 p.m. on the specified deadline. If you have a Qenek account, you may cancel your existing direct deposit instruction online via the portal.

## Address Changes

Checks are mailed to the address CIRI has on record as of the specified deadline. If your address has changed, be sure to update your address with both CIRI and the U.S. Postal Service. These addresses must match, or your CIRI mail may not reach you. When CIRI mail is undeliverable, distributions are held, and the Shareholder does not qualify to participate in any prize drawings until the address is updated. This is true even if a Shareholder is signed up for direct deposit.

CIRI address changes may be submitted online via the Qenek portal. Alternatively, you may submit a completed CIRI address change form—available at [ciri.com](http://ciri.com)—or a signed, written request that includes a current telephone number. You may scan or take a photo of your completed form or request and email it to [shareholderrecords@ciri.com](mailto:shareholderrecords@ciri.com), mail it to CIRI at P.O. Box 93330, Anchorage, AK 99509, or fax it to (907) 263-5186. If faxed, please call Shareholder Relations as soon as possible to confirm receipt. Forms and information on changing your address or submitting a mail-forwarding request with the U.S. Postal Service are available at [usps.com](http://usps.com) or your local post office.

Please be aware that if you fail to notify CIRI of a new address before a specified deadline and your check is sent to your previous address, CIRI cannot reissue that check to you unless it is either returned to us, or a minimum of 90 days has elapsed. A list of Shareholders who do not have a current mailing address on record is continually updated and may be found on the CIRI website.

## Tax Reminder

Neither CIRI nor the CST withhold taxes from distributions; however, Shareholders or beneficiaries who anticipate owing tax on their distributions have the option of making quarterly estimated tax payments directly to the IRS. To find out more about applicable federal and state tax requirements or making quarterly estimated tax payments, please consult with a tax advisor or contact the IRS directly. As a reminder, distributions made by the CST are expected to be tax-free to beneficiaries in most cases.

# MAPLE SPRINGS GRAND OPENING

## Assisted Living and Memory Care Facility Opens in Anchorage

For many years, Alaska's senior housing market has struggled to meet the needs of its older residents. Exacerbating the housing shortage is Alaska's senior population: Though residents ages 65+ account for only 13% of the state's overall population, the demographic is expected to double by 2034, far outpacing the national average (139% versus 81% growth).

As assisted living opportunities will become increasingly important to meet Alaska's health-care needs, CIRI invested in Maple Springs Anchorage in 2019, a state-of-the-art assisted living, memory care, and skilled nursing and rehabilitation facility.

Maple Springs Anchorage opened to residents in February, and a grand opening celebration was held July 13. CIRI executives and employees, community members and the general public were invited to take part in the festivities, which featured food, door prizes and live entertainment.

Maple Springs Anchorage was built on CIRI-owned land in South Anchorage. The 107,500-square-foot facility features 79 assisted living units and 28 memory care units. A skilled nursing facility is scheduled to open in late 2024, and additional land acreage is available for future expansion.
