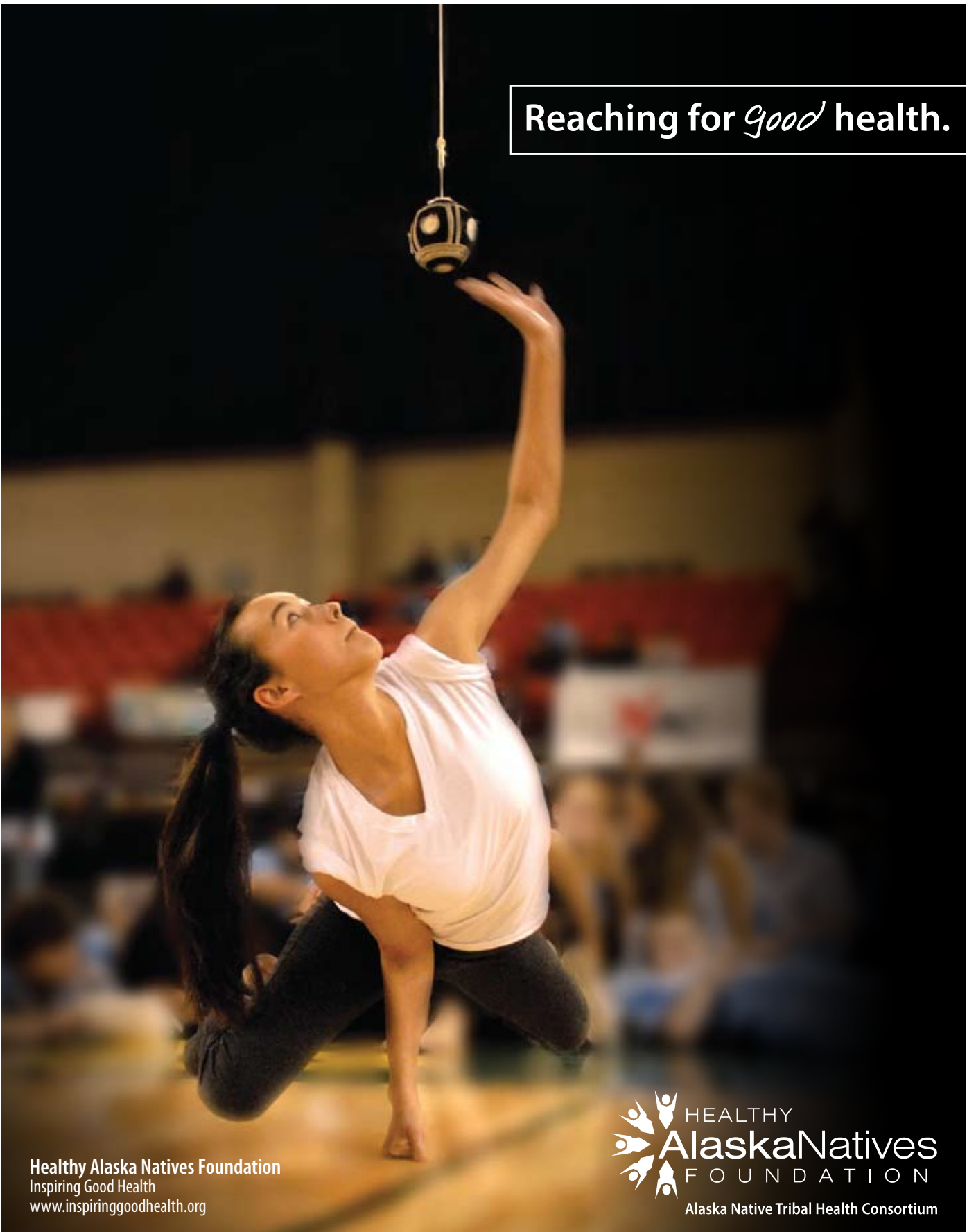

## Noel Strick

I was raised in King Cove, Alaska until the age of ten. My father Dennis Gould is Aleut and from King Cove. My mother is Martha Gould-Lehe who is Athabascan from McGrath.

My Clark Junior High Indian Ed Counselor, Lucy Brown, recruited me for Native Youth Olympics in seventh grade. My first coaches were Brian and Shelia Randazzo. I have continued to coach, organize, and judge the traditional Native games.

I have learned so much more about the strength, determination, and beauty of our people because of the traditional Native games. The games have become a part of my life, and the people who show up at the games have become part of my extended family. My husband Robert competes in the Dene games. My son Forest competes in NYO. My daughter Alice competes in the games, and is the current world record holder for one-foot high kick and state record holder for two-foot high kick. I look forward to the day when my twins will play the games.

It is important to me that we strengthen our youth. That is why I have chosen to become a teacher as well as pass on our games. <

## Sanford 'Sam' Strange

My name is Sanford "Sam" Strange. I am Cupik Eskimo, growing up in Bethel, Alaska, now residing in Anchorage since 2000. I have been brought up to understand and respect my cultural values of hunting, fishing, respect for my elders and dance, while at the same time blending this with modern life today. In 1997 I was elected to the Bethel Emergency Services Board as the Vice President, then President until 2000. I have started and owned my own business in construction since 2008. I have participated in the Native Youth Olympics since 1988. Coached and judged the games since the late nineties, and helped oversee NYO games of Alaska since 2005. In 2005 I was nominated to be the Inuit Games coach for Team Alaska for the Arctic Winter Games and have played this role since. In 2008, I was elected to the World Eskimo Indian Olympics Board, while also participating in their games to this date. In 2006 I was picked and served on the State of Alaska CASA board until 2008.



I am married to my wonderful wife Michelle with two kids; my son Seth, who is five, loves the outdoors and games. My daughter Shelby, who is three, also loves the outdoors and games. To this day I still go hunting, fishing, clamming, berry picking, with my wife and kids, instilling the traditional values I have learned. <

## Thomas E. Akelkok

I was born in Dillingham and raised in Ekwok, Alaska. I graduated from Mt. Edgecumbe High School in 1988. I am a proud father of two wonderful boys. I participated in NYO for two years, competing in the one foot high kick and seal hop. I have always been very competitive throughout my life. I also wrestled my Jr. and Sr. years in high school and went on to take the State Championship title at the 171 weight pound class in 1988.



After high school, I worked as a carpenter for several years and joined the Local 1281 Carpenters Union. I also spent several years working on the North Slope as a General Foreman for field construction. In 1998, I joined the Alaska State Troopers. I have served as a Wildlife Trooper in Big Lake, Sitka, and Mat-Su areas. Thank you, CITC, for all that you do for Alaskans. <

NYO Games Alaska helps to develop healthy lifestyles, positive self esteem, leadership, and teamwork. The Games promote good sportsmanship, and foster understanding between diverse communities and cultures. # KNEEL JUMP

When it comes to the Kneel Jump, appearances can deceive, as it is impossible to predict winners based on physique. The athlete starts in a kneeling position, with the tops of the feet flat on the floor, and then jumps up and forward. Athletes must land on both feet simultaneously and remain in that position without moving, and without otherwise touching the floor. Each athlete is allowed three attempts. The winner is the contestant who jumps the greatest distance.

# WRIST CARRY

The Wrist Carry is tailor made for small, muscular athletes – who also have a will of iron. Starting from a sitting position, the athlete hooks one wrist over the middle of a long pole held by two carriers. Without touching the pole with any other part of the body, the athlete lifts him- or herself off the floor, maintaining this position while carried over the course (carriers can walk or run), until he/she can no longer hold their weight. The contestant that covers the greatest distance while suspended wins.

# ALASKAN HIGH KICK

A tour-de-force of body and mind, the Alaskan High Kick is one of the most elegant and photographed of the games. To prepare for the kick, the athlete sits on the floor and balances on one foot while reaching across the torso to hold the other foot. Leaning back on the opposite hand, the athlete thrusts the balancing foot straight up to kick the ball, and then lands on the kicking foot – without losing balance. The ball is raised in increments of 4” after each round, and each athlete is allowed three attempts at each height. When all but three athletes have been eliminated, the ball is raised in 1” increments, until there is a winner.

# ESKIMO STICK PULL

The Eskimo Stick Pull is a contest of sheer strength and determination. Two contestants sit on the floor facing each other, the soles of their feet touching. Feet must be parallel and together, with knees bent at a 45-degree angle. Barehanded, with palms facing the floor, contestants firmly grasp a stick placed between them. (A coin toss determines which contestant has the inside or outside hold on the stick.) On a signal, contestants try to pull the stick away from their opponent, without jerking or re-setting their grip. A contestant wins a round when their opponent is pulled off the floor, falls over sideways, or releases their grip. Hand positions are alternated between rounds. The winner of two rounds takes the match and moves to the next heat.

# TOE KICK

A favorite of many spectators, the Toe Kick requires both strength and airborne agility. Starting from a standing position behind a line, athletes jump with feet together over a stick, tapping it with the toes before landing on both feet. After each round, the stick is moved in 4” increments away from the start line. When all but three athletes have been eliminated, the stick is moved in 1” increments, until there is a winner.

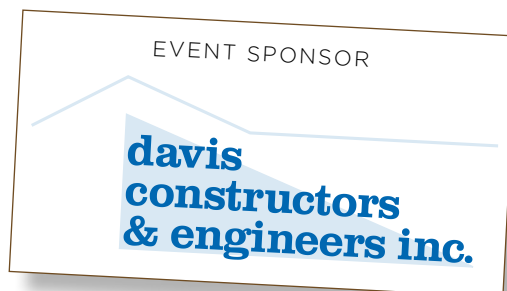

# ONE HAND REACH

The One Hand Reach demands extraordinary balance, strength, and focus. Balancing their weight on the palm or knuckles of one hand, the athlete reaches with his/her free hand to touch a suspended ball, and then places the free hand on the floor – without otherwise touching the floor. The ball is raised in increments of 4” after each round, and each athlete is allowed three attempts at each height. When all but three athletes have been eliminated, the ball is raised in 1” increments, until there is a winner.

# TWO FOOT HIGH KICK

The Two Foot Kick is a supreme test of abdominal strength and balance. Jumping with both feet simultaneously, the athlete kicks the ball, and then lands on both feet without falling backwards. The ball is raised in increments of 4” after each round, and each athlete is allowed three attempts at each height. When all but three athletes have been eliminated, the ball is raised in 1” increments, until there is a winner.

# INDIAN STICK PULL

Smaller athletes can prevail over much bigger ones in the Indian Stick Pull (a stepstool may even be provided if there is a large difference in height). Two contestants stand next to each other, facing in opposite directions. Each places their near foot forward and alongside the outside of their opponent's. Feet must be kept on marked positions, and no other body contact is allowed. With their near arms held down, each contestant grabs the opposite end of a tapered and greased wooden dowel. On the signal to start, each athlete pulls, attempting to pull the stick out of their opponent's hand. During the competition, the stick cannot be raised any higher than the tallest opponent's shoulder. No body contact is allowed. Jerking, twisting or turning the stick is allowed and feet must remain in place on the floor. Movement of the feet will result in the player losing that pull. The contestant that pulls the dowel from the other's hand, or pulls it past their opponent's hip for ten seconds, wins the round. Matches consist of three rounds – first with the right hand, then with the left, and the third (if needed) with the hand determined by coin toss. The winner of two rounds takes the match and moves to the next heat.

# ONE FOOT HIGH KICK

The One Foot High Kick demands great flexibility and leg strength. From a standing or running start, the athlete jumps with both feet, kicks the ball with one foot, and then lands on the kicking foot – without losing balance (he/she may hop several times on the kicking foot to re-gain balance). The ball is raised in increments of 4” after each round, and each athlete is allowed three attempts at each height. When all but three athletes have been eliminated, the ball is raised in 1” increments, until there is a winner.

# SEAL HOP

The Seal Hop is perhaps the most physically and mentally grueling of all the events. In the girls' Seal Hop, contestants assume a push-up position with arms straight and palms flat on the floor. On a signal, the contestant hops – seal-like – across the floor on their hands and toes, while maintaining the push-up position. When their shoulders cross a designated marker, they must make a 180-degree turn and resume hopping. Athletes will be stopped for pausing and restarting, raising the rump above the shoulders, or touching the floor with their knees or stomach. Upon completing their distance, the contestant must remain in position until the judge measures their distance. The athlete who travels the greatest distance is the winner. In the boys' Seal Hop, contestants must maintain a lowered push-up position, with elbows bent, hands curled and knuckles down, supporting their weight on the heels of the hands and knuckles.

## Nakenu Family Center

Nakenu Family Center is a comprehensive mental health and chemical dependency treatment facility. Licensed professional staff members strive to provide culturally relevant and evidence-based counseling services to local Tribal members, Alaska Natives, and the overall community.

**Chemical Dependency Program:** works with individuals and families whose lives have been impacted by substance abuse or dependency. Certified Chemical Dependency Counselors provide assessments and placement within the appropriate level of care. Early Intervention, Outpatient, and Continuing Care services are available on-site, as well as assistance in transitioning to residential treatment facilities. Staff members focus on cultural and family strengths to assist individuals in achieving abstinence and maintaining a program of recovery. Day and evening groups facilitate the availability of these services for both adult and adolescent populations. This program promotes increased mental, spiritual, and physical health.

## WOMEN'S HEALTH

### The Breast and Cervical Cancer Early Detection Program

Started in 1994, provides screening services (mammograms, clinical breast exams, pap smears) to Alaska Native and American Indian women in the Anchorage Service Unit, focusing on services to women ages 40–64. Program staff specializes in providing quality services, and promoting women's wellness, and the enhancement of the quality of life. The program offers ongoing one-on-one and group client education, focusing on breast and cervical cancer awareness, risk factors, and the benefits of early screening. Staff also provides tracking, follow-up, and case management services, public education and outreach services, and professional education services. The Breast and Cervical Cancer Early Detection Program is funded by grants from the Centers for Disease Control and Prevention and the Avon Breast Care Fund.

Provides full-spectrum obstetric and gynecological (OB/GYN) care for adult women. The staff includes board-certified OB/GYN physicians, nurse practitioners, certified nurse midwives, registered nurses, licensed practical nurses, certified medical assistants, management, and administrative support.

## YOUTH PROGRAMS

### Yaghanen Youth Programs

Yaghanen is the prevention and early intervention program of the Tribe. *Jabila'ina Dance Group* promotes Dena'ina language and cultural activities in song and dance. Traditional values stories, and interaction with Tribal Elders encourages youth to make healthy life choices. *Ggugguyni Native Youth Olympics Team* highlights development of individual physical well-being through practicing events that require strength,

balance, endurance, and coordination. This year's program incorporates a strong emphasis on community services and academic success. *Del Dumí Intertribal Drum* is a collaboration with the Nakenu Program. Singing traditional drum songs and participating in drum performances encourages sobriety, respect, and pride. **Youth camps** provide an opportunity to expand and highlight the positive choices offered to our youth during after-school programs while expanding our emphasis on cultural preservation, subsistence, and traditional practices, and healthy life skills. They include: Ke'tedihłchiłt (Native Arts Camp), Łuq'a Dnagh Tdigheleh (Fish Camp), Susten (Archaeology Camp), Dnigi Camp (Moose Camp). **Tutor services** are offered four days a week to further encourage educational success and achievement. This year's program incorporates a strong outreach to local schools and other youth programs and agencies. *Dena'ina Language Program* – The goals and objectives of the Dena'ina language program are to revitalize, teach, and preserve the Outer Inlet dialect of the Dena'ina language. This is accomplished through collaboration with other tribal programs, KPC, UAF, the Alaska Native Heritage Center, and other Dena'ina tribes to develop curriculum, technological resources, and qualified language teachers. Our Tribal Elders are critical to the success of this program and we rely on their knowledge, participation, and comments.

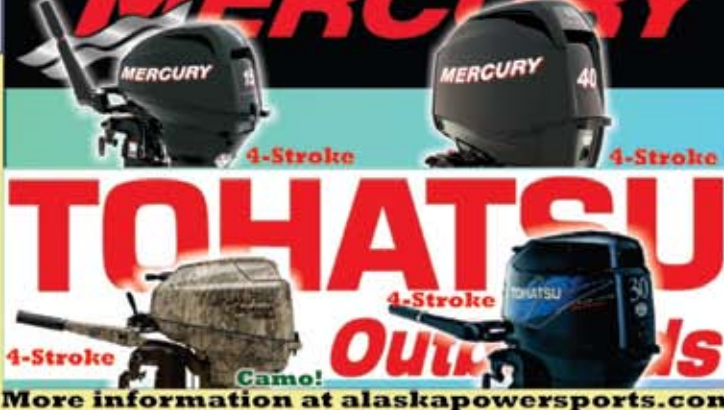
