CIRI PRIZES AND PAYMENT OPTIONS

CIRI holds periodic prize drawings from the names of those enrolled in various programs who meet certain criteria and have a current mailing address with CIRI. If CIRI has returned mail for the selected individual, a different winner is selected.

STOCK WILL PRIZES: Shareholders with a valid will on file that complies with CIRI's fractional share policy are automatically entered into monthly and quarterly prize drawings. Even if you have a will on file, please remember to update it after giving or receiving a gift of stock, upon the death of a designated beneficiary or if additional shares are inherited. Marriage, divorce, the birth or adoption of children and other life changes are also reasons to complete a new will. Learn more at www.ciri.com/wills.

QENEK PORTAL PRIZES: Qenek is a free, secure, online portal where eligible shareholders may access information about their stock and payments and perform certain tasks online, reducing the need for paper forms. Quarterly prize drawings are conducted from the names of all shareholders with Qenek accounts who have accessed the account during the preceding quarter. eNEWSLETTER PRIZES: Quarterly drawings are conducted from the names of shareholders enrolled in the eNewsletter program who have a valid email address on file. To enroll, call Shareholder Relations at 907-263-5191 or 800-764-2474 (select option 0) or send an email that includes your full name and a good telephone number to shareholderrecords@ciri.com.



ANNUAL MEETING PRIZES: To encourage participation and ensure the presence of a quorum, voting shareholders are eligible to participate in cash prize drawings in connection with CIRI's Annual Meetings of Shareholders. Prize amounts and rules are annually announced.

CONFIRMED DESCENDANT PRIZES: CIRI encourages the next generation to become involved with their corporation. Do you know any direct lineal descendants of a CIRI shareholder who are not shareholders themselves? Descendants who register with CIRI and have a valid email address on file are eligible to participate in a quarterly prize drawing and other opportunities. Learn more at www.ciri.com/descendants.

DIRECT DEPOSIT PRIZES: Shareholders whose CIRI distributions are directly deposited are eligible to participate in \$500 quarterly prize drawings, with winnings deposited to the bank account designated in CIRI's records. If the funds are rejected by the bank, another winner is selected. **Not enrolled, or enrolled but need to change your direct deposit instruction? Remote deposit of paper checks: Not interested in direct deposit? Many banks offer "remote deposit" technology. With remote deposit, you won't have to drive to the bank or stand in line and checks may be deposited anytime of the day or night and on any day of the week.
