GIFTOR'S DECLARATION

I affirm that I have not received anything of value, nor was I promised anything of value in compensation for the shares I wish to gift and that I execute this instrument as my free and voluntary act for the purposes expressed in it, that I am 18 years of age or older, of sound mind, and under no constraint or undue influence.

I acknowledge that I have received and read the information contained in the CIRI *Inter Vivos* Stock Gifting packet, which explains the consequences and tax considerations of transferring shares of stock as an *Inter Vivos* gift.

I have read, understand, and agree to the above and affirm that the information I have provided to CIRI is true.
