## **CIRI's 2019 Next Generation Day**

### **Call for themes and corresponding original artwork!**

**About Next Generation Day:** Each January, CIRI hosts Next Generation Day (formerly Take the Next Generation to Work Day). Young CIRI shareholders and descendants are invited to spend the day at CIRI learning about the company, exploring future career paths and participating in Alaska Native cultural activities. The day is intended to get the next generation excited about CIRI and foster future engagement with the company. 2019 Next Generation Day will be held Monday, Jan. 21 at CIRI's corporate offices in Anchorage.

**Pop-Up Art Contest:** Through a theme and corresponding original artwork, CIRI shareholders and confirmed, registered descendants 10 years old through high-school age are invited to interpret the question, "What does CIRI's Next Generation Day mean to YOU?" Entrants need not have participated in or be planning to attend Next Generation Day.

Original artwork (drawing, painting, photograph, etc.) should measure no larger than 8.5 by 11 inches and correspond to the artist's proposed theme. Please provide an explanation of the connection between the theme and artwork.

**When:** Original artwork and themes, along with the attached entry form, must be mailed or dropped off in person and received by CIRI no later than 5 p.m. Friday, Jan. 4, 2019.

#### **Guidelines:**

- Artwork should not feature images of identifiable people unless accompanied by a signed and dated release form. Release forms must include each person's full name, contact information and a statement authorizing use of his or her image.
- Entries for those under the age of 18 must be accompanied by the signed Parent/Legal Guardian Acknowledgement and Agreement.
- Entries not selected for prizes may be returned upon advance written request. CIRI shall not be liable for damage to any entries.
- Entries will be reviewed by a selection committee and judged on a range of factors, including artistic quality, originality and theme connection to Next Generation Day. At CIRI's discretion, the winner's photograph, name, city/state, Alaska Native cultural affiliation and reproductions of his/her artwork may be published in CIRI's print and online materials.
