## **GUIDELINES**

1. CIRI shareholders and descendants age 5-12 may submit one entry each.
2. Entries should be original artwork (such as drawings, paintings, original prints, photographs, etc.) measuring no larger than 8-1/2" x 11."
3. Submitted artwork must in some form demonstrate the designated theme. If desired, an explanation of how the artwork represents the theme may be included on a separate page accompanying the entry.
4. Artwork should not feature images of identifiable people unless accompanied by a signed and dated release from each such person that includes his or her name, contact information and a statement authorizing the use of his or her image.
5. Each entry must be accompanied by an entry form completed by the child's parent or legal guardian.
6. Entries not selected for prizes may be returned upon advance written request. CIRI shall not be liable for damage to any entries.
7. Entries will be reviewed by a selection committee and judged on a range of factors -- including artistic quality, originality, and strength of expression in conveying the concepts involved -- and winners will be contacted. At CIRI's discretion, the winners' photographs, names, communities, cultural affiliations and reproductions of their artworks will be published in CIRI's print and online materials, including the CIRI newsletter, and their entries displayed at CIRI's fall potlatches.

Original artworks and completed entry forms must be received by CIRI Shareholder Relations on before 5:00 p.m. Alaska Daylight Time on August 11, 2021.
